within the corporate limits of any  
incorporated city, village, or  
borough; and

WHEREAS, this territory abuts  
upon the corporate limits of the  
City at the easterly boundary  
thereof and is deemed to be ur-  
ban in character; and

WHEREAS, This territory is  
owned in fee by the City;

The City Council of Cannon  
Falls ordains:

Section 1. Territory Annexed.  
The corporate limits of the City  
of Cannon Falls are hereby ex-  
tended to include the unplatted  
property described as follows now  
owned by the City:

The West half (W $\frac{1}{2}$ ) of the  
Southeast Quarter (SE $\frac{1}{4}$ ) ly-  
ing south of the Big Cannon  
River and all of the South-  
west Quarter (SW $\frac{1}{4}$ ) lying  
between the Big Cannon  
River and the Chicago Great  
Western Railway right-of-way,  
all in section 8, in township  
112 north, of range 17 west;


