COMMUNITY BUILDING

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF
INTERNATIONAL FALLS TO INCLUDE CERTAIN UNINCORPORATED TERRI-
TORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS
AND ABUTTING THEREON

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the city and is deemed to be urban in character;

The City Council of International Falls ordains:

Section 1. Territory Annexed. The corporate limits of the city of International Falls, Minnesota, are hereby extended to include the platted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits.

Commencing at a point formed by the intersection of the extension of a line drawn extending the southerly boundary of Eleventh Street, Plat of International Falls and the northwest boundary of the right-of-way of Trunk Highway 11-71; thence northeasterly along said boundary of Trunk Highway 11-71 to a point formed by the intersection of said boundary of Trunk Highway 11-71 and an extension of the center line of Fourteenth Avenue, Plat of International Falls; thence at a right angle to the east along said extension of the center line of Fourteenth Avenue to a point formed by the intersection of the extension of said center line and the southwest boundary of the right-of-way of Trunk Highway 11-71; thence at a right angle southwest along the southwest boundary of Trunk Highway 11-71 to a point formed by the intersection of said southwesterly boundary and the southerly boundary of Eleventh Street, Plat of International Falls, thence at a right angle to the point of commencement.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Section 3 Effective Date of Annexation. This ordinance takes effect thirty days from and after its passage and publication and the filing of certified copies as directed in Section 2.
