AN ORDINANCE EXTENDEDG THE CORPORATE LIMITS OF THE CITY OF INTERNATIONAL FALLS TO INCLUDE CERTAIN UNINCORPORATED TARRI-TORY COMPLETELY SURROUNDED BY LAND LITTLE THE CITY LIBITS AND ABUTTING TERREOR

THEREAS, certain territory described below is not precently included within the corporate limits of any incorporated city, village, or borough; and

MERRAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the city and is deemed to be urban in character;

The City Council of International Falls ordains:

Section 1. Territory America. The corporate limits of the city of International Falls, Ninn-esota, are hereby extended to include the platted territory described as follows, which territory now is and has herebosote been completely surrounded by territory already included within the city limits.

Commencing at a point found by the intersection of the entension of a line drawn extending the southerly boundary of Eleventh Street, Flat of International Falls and the northwest boundary of the right-of-way of Trunk Highway 11-71; thence northeasterly along said boundary of Trunk Highway 11-71 to a point formed by the intersection of said boundary of Trunk Highway 11-71 and an extension of the center line of Fourteenth Avenue, Plat of International Falls; thence at a right angle to the east along said extension of the extension of Fourteenth Avenue to a point formed by the intersection of the extension of said center line and the southwest boundary of the right-of-way of Trunk Highway 11-71; thence at a right angle southwest along the southwest boundary of Trunk Highway 11-71 to a point formed by the intersection of said southwesterly boundary and the southerly boundary of Eleventh Street, Plat of International Falls, thence at a right angle to the point of commencement.

<u>Section 2. Filing</u> The city clerk is directed to file certified copies of this ordinance with the secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Section 3 Effective Date of Annewation. This ordinance takes effect thirty days from and after its passage and publication and the filing of certified copies as directed in Section 2.
