# MOTOR VEHICLE RECIPROCAL PRIVILEGES BETWEEN THE PROVINCE OF ONTARIO, DOMINION OF CANADA AND THE STATE OF MINNESOTA, U. S. A.

### A MEMORANDUM OF UNDERSTANDING

The duly authorized officials of the State of Minnesota, through authority granted by law, hereby extend certain reciprocity privileges for use of the highways to motor vehicle owners, residents of the Province of Ontario, Canada, with the understanding that equal privileges are extended to residents of Minnesota by the Province of Ontario. The reciprocal privileges hereinafter stated are less than that authorized by Minnesota law but such provisions are necessarily limited to these conditions because of the Ontario law which will not grant greater privileges to Minnesota residents.

PASSENGER AUTOMOBILES, MOTORCYCLES, MOTOR SCOOTERS, HOUSE TRAILERS AND PASSENGER CAR UTILITY TRAILERS

Full reciprocity is extended to owners of vehicles as described above for a period not to exceed three (3) months in any one year including students attending school or college, even though such owners may be temporarily employed during such period.

II.

#### AMBULANCES, HEARSES AND BUSES

Full reciprocity is extended to owners of ambulances and hearses used only in interstate operations, and to owners of buses operating on a chartered trip in interstate commerce.

Full reciprocity is extended to other public transportation buses operated in a scheduled service within ten (10) miles of the point of entry on the international boundary line between Minnesota and Ontario.

#### III.

## TRUCKS, TRACTORS, TRUCK-TRACTORS, TRAILERS AND SEMI-TRAILERS OR COMBINATIONS THEREOF

Full reciprocity is extended to owners of such vehicles or combinations as described above in this section when operated in interstate commerce under the following conditions:

- (1) The gross weight does not exceed 6,000 pounds and the goods transported are owned by the owner of the vehicle or combination of vehicles;
- (2) The vehicle or combination of vehicles is operated for the purpose of transporting from a farm, natural products of a farm or livestock, or both, owned by the owner of the vehicle or combination of vehicles, or
- (3) The vehicle or combination is operated for the purpose of transporting objects and materials used in the production of cultural exhibitions or presentations, including musical and ballet presentations and art exhibitions, if such presentations or exhibitions are not carried on solely for the purpose of financial gain.

Full reciprocity is extended to owners of trailers or semi-trailers registered in Ontario when drawn by a truck or truck-tractor registered in Minnesota and operated within ten (10) miles of the point of entry on the international boundary between Minnesota and Ontario provided in the case of truck-tractors the registered gross weight must be sufficient to cover the entire gross weight of the combined vehicles.

#### IV.

Any other vehicles or combinations not covered by the memorandum of understanding must be fully registered in accordance with the laws of Minnesota the same as like vehicles owned by Minnesota residents provided, however, that in the case of a truck or truck-tractor or combination of truck-trailer or truck-tractor semi-trailer owned by a resident of Ontario transporting goods owned by such owner which is not exempted by provisions of section III hereof, a 5-day permit may be issued upon payment of a fee of \$20.

It is understood that all vehicles entitled to full or partial reciprocity shall be properly registered in Ontario, and further, that nothing contained herein shall be construed to apply to commercial vehicles operating in intestate commerce, or to waive compliance with the weight, dimension or traffic laws of Minnesota.
