ORDINANCE NO. 365  
AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WHITE BEAR LAKE  
TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES

Section 1. A petition has been filed with the governing body of the City of White Bear Lake, Minnesota, by the sole owner of the following described real estate to have such land included within the City of White Bear Lake, Minnesota;

The East one hundred forty-five (E.145) feet of the West four hundred seventy five and seven hundred thirty seven thousandths (W.475.737) feet of the South two hundred ninety five and one hundred fifty eight thousandths (S.295.158) feet of the North three hundred twenty eight and one hundred fifty eight thousandths (N.328.158) feet of the North-east one quarter (NE 1/4) of Section Thirty-five (35) Township thirty (30) Range Twenty-two (22) according to the United States Government survey thereof.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, does not exceed two hundred (200) acres.

Section 3. The City Council hereby determines (1) that the annexation will be to the best interests of the City of White Bear Lake, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. Therefore, the City of White Bear Lake, Minnesota, hereby ordains and declares that the property hereinbefore described by and the same is hereby annexed to, and included in, the City of White Bear Lake, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing Certified copy thereof with the Minnesota Municipal Commission, the County Auditor and Secretary of State, and from and after its passage and publication.
