Sec. 1. Whereas, a petition has been received for the annexation to the City of Albert Lea of the following described properties:

Beginning 739.47' North and 379.5' East of the Southwest Corner of Lot 24 of Webber's Subdivision in the Northwest Quarter of Section 16, Township 102 North, Range 21 West; thence 222.22' Northwesterly on the Northwesterly right-of-way of U. S. Frank Highway No. 16 and 45; thence 312.21' Northwesterly as a deflection angle of 57° 14' left; thence 92.40' Southwesterly on the Southwesterly right-of-way line of Stevens Street; thence 10.0' Southwesterly on said right-of-way; thence 104.33' Southwesterly on the right-of-way line of said Stevens Street; thence 10.0' Northwesterly on said right-of-way; thence 270.23' Southwesterly on said right-of-way line of said Stevens Street; thence 206.77' South on a line parallel to the West line of Lot 26 of said Webber's subdivision to the point of beginning; being in the West half of the Northwest Quarter of Section 16, Township 102 North, Range 21 West;

also

the South 1/2 of Stevens Street and the whole of East Main Street abutting on the above described property, and less that portion of Lot 26 within subdivision included in the above description which portion is now within the limits of the City of Albert Lea.

Sec. 2. The quantity of land embraced within the foregoing description and located as described is 11.03 Acres.

Sec. 3. The City Council hereby determines: (1) That the annexation will be to the best interest of the City of Albert Lea, Minnesota and of the territory affected; (2) That the territory described herein abuts upon the City and is so conditioned as to be properly subjected to City government.

Sec. 4. The City of Albert Lea hereby declares that the property above described to and the same is hereby annexed to and included in the City of Albert Lea, Minnesota as effectually as if it had originally been a part thereof.

Sec. 5. The above described property is hereby designated as C - 2 General Commercial District zoning, and shall be so indicated on the zoning District Map.

Sec. 6. This annexation shall be deemed final and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, County Auditor and the secretary of State and from and after its passage and publication.
