RESOLUTION CANVASSING THE VOTES ON AMENDMENTS TO THE HOME RULE CHARTER AT THE SPECIAL ELECTION

WHEREAS; A Special Election was held in the City of Chisholm to vote on four amendments to the Home Rule Charter and the Judges of the Election Board of the various precincts in said City have duly made their returns of the votes cast at said election and the City Council has duly tanyassed the said returns and ascertained the results of said election as follows:

CITY ELECTIONS

apunding of Section 9

1. Shall Section 9 of the Home Rule Charter of the City of Chisholm be amended to read as follows:

"Section 9. All matters relating to Municipal Elections, whether general or special, shall be governed by the applicable election laws of the State of Minnesota."

YES received 2,122

NO received 421

CITY ELECTIONS

APOLISHMENT OF SECTIONS 10, 11, 12, 14, 15, 16 and 17

20 Shall Sections 10, 11, 12, 14, 15, 16 and 17 of Chapter II of the Home Rule Charter of the City of Chisholm, described as follows, be abolished:

"Section 10. Registration of Voters; Section 11. Filing of Candidates for Office; Section 12. Ballots, Names, How Printed; Section 14. Officers, of Election; Section 15. Absent Voters; Section 16. What Shall Constitute an Election; Section 17. Special Elections.

CITY ELECTIONS

AMENDING OF SECTION 8

3. Shall Section 8 of the Home Rule Charter of the City of Chisholm be amended to read as follows:

"Section 8. Date of Election. There shall be an annual City Election held each year, consisting of a Primary City Election, held on the first Tuesday after the first Monday of November each year and followed thereafter by a General Municipal Election, held on the first Tuesday after the first Monday of December. Special Elections may be held for any purpose by ordinance or resolution of the City Council.

POWERS AND DUTIES OF CITY COUNCIL

44 Shall Section 80 of the Home Rule Charter of the City of Chisholm be amended to read as follows:

"Section 80, Organization. The city council shall annually on the first Tuesday in January next succeeding the regular municipal election, organize, and at the time of its organization, proceed to elect from its own number a President and Vice-President for the ensuing one year, and such other officers as may be necessary for the transaction of its business. Such election shall be by ballot, and the affirmative vote of a majority of all the members shall be necessary to elect."

YES received 1,865

NO received 551

NOW, THEREFORE, BE IT RESOLVED, That the amendments were favored by the required fifty-five per cent of the voters who voted on the amendments at the Special Election held on the 3rd day of December, 1963, as provided by **Chapter** 305, Laws of Minnesota, and are hereby declared carried and that said amendments be declared adopted and become a part of the Home Rule Charter of the City of Chisholmo
