

ORDINANCE NO. 241

VILLAGE OF ADRIAN, NOBLES COUNTY, MINNESOTA

AN ORDINANCE AMENDING TERRITORY TO THE VILLAGE OF ADRIAN

WHEREAS, The tract of land hereinafter described is unplatted, abuts on the Village of Adrian, and is not included in any other municipality,

AND WHEREAS, All of the owners of such tract hereinafter described have heretofore petitioned the Village Council to have such land included within the Village of Adrian,

AND WHEREAS, The Village Council finds and determines that the annexation of the above property will be in the best interests of the public of the Village of Adrian and of the said territory,

AND WHEREAS, The annexation of such territory under the above circumstances is authorized by Minn. Stats. 1961, Sec. 414.03, Subdivision 2.

Be it ordained by the Village Council of the Village of Adrian as follows:

Section 1. The following described tract of land is hereby annexed to the Village of Adrian:

A tract of land in the Northeast Quarter (NE $\frac{1}{4}$) of Section 24, T. 102 North, Range 43 West, described as follows: Commencing at the northeast corner of said Section 24, thence southerly along the east line of said Sec. 24 for 749.00 feet to the point of beginning; thence westerly along the south line of Maple Street, Village of Adrian, Minnesota, for 775.00 feet, thence southerly and parallel to the east line of said Sec. 24, for 170.00 feet, thence easterly and parallel to the south line of said Maple Street, for 583.00 feet, thence southerly and parallel to the east line of said Sec. 24, for 80.00 feet, thence easterly and parallel to the south line of said Maple Street, for 190.00 feet to the east line of said Section 24, thence northerly along said east line of Section 24, for 250.00 feet to the point of beginning, containing an area of 3.14 acres, more or less, and subject to easements for highway purposes now in effect; being in Nobles County, Minnesota.

Section 2. This order shall be effective upon its passage and publication, and upon filing a copy thereof with the Minnesota Municipal Commission, the Auditor of Nobles County, and the Minnesota Secretary of State.
