ORDINANCE NO. 208

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ST. PETER TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 800 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS A certain petition dated October 29, 1963, and an Amended Petition dated November 15, 1963, requesting annexation of the territory hereinafter described as duly presented to the Council on the 29th day of October, 1963, and Tovember 15, 1963; and

WHEREAS The quantity of land embraced within the area described in the petition and bounded as described is 9.1 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS The perition was signed by all owners; and

WHEREAS No objections to the annexation have been received from the tewn board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS The land described in the petition abuts upon the city limits at the

westerly boundary theref;

The Council of the City of St. Peter, Minnesota, ordains:

Section 1: The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abute upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory now included within the limits of any city, village or borough.

Section 1: Territory Annexed. The corporate limits of the city hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a

part thereof;

Commencing at the Northeast corner of Section Seventeen (17), Township One Hundred Ten (110) North, Range Twenty-six (26) West; thence South along the East line of Section Seventeen (17), 1318.6 feet to the centerline of County Road #15 and the point of beginning of the following described tract; thence continuing South along the East line of said Section Seventeen(17), 669.5 feet; thence deflecting right 89 degrees his minutes, 456.0 feet; thence deflecting right 90 degrees 16 minutes and parallel to the East line of Section Seventeen (17), 669.5 feet to the centerline of County Road #15, thence deflecting right 89 degrees his minutes and along the centerline of said County Road 456.0 feet to the point of beginning, subject to easements of record for public highways and containing 6.0 acres of land, more or less, excluding highway right-of-way. (Assembly Homes, Inc., property)

Commencing at the Northeast corner of Section Seventeen (17), Township One Hundred Ten (110) North, Range Twenty-six (26) West: thence South along the East line of Section Seventeen (17), 1988, feet to the point of beginning of the following described tract; thence continuing south along the East line of said Section Seventeen (17), 113.75 feet; thence deflecting right 89 degrees lip minutes, 456,0 feet; thence deflecting right 90 degrees 16 minutes and parallel to the East line of Section Seventeen (17), 413,75 feet, thence deflecting right 89 degrees

hu minutes, 456.0 feet to the point of beginning, subject to easements of record for public highway and containing 4.0 acres of land, more or less, excluding highway right-of-way. (Assemblies of God Church Property)

Excepting, however, the following described bract, which was previously annexed to the City of St. Peter, to-wit:

Beginning at the East quarter corner of Section Seventeen(17) Township One Hundred Ten (110) North, Range Twenty-Six (26) West; thence South along the East line of said Section Seventeen (17) a distance of 571.2 feet to the point of curvature of a 50-01 -03" curve and a delta angle of 20-52, the tangent of said curve being a portion of the afore described line; thence northerly, deflecting left along the above described curve a distance of 571.33 feet along the curve; thence continuing on tangent to said curve bearing North 20-52 West a distance of 228.8 feet; thence deflecting to the right on a 40-58"-57" curve with a delta angle of 20-52" for a distance of 575.33 feet along the curve; thence continuing on a tangent to said curve bearing North a distance of 552.7 feet; thence East 40 feet to the East line of Section Seventeen (17); thence south and along the East line of said Section Seventeen (17) a distance of 1355.1 feet to the point of beginning. Said tract contains of acres.

Section 3: Filing. The City Clork is hereby directed to file certified capies of this ordinance with the Minnesota Municipal Commission, the Secretary of The City Clork is hereby directed to file certified State, and the County Auditor.

Section its Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
