ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES, PUR-SUANT TO CHAPTER 686, LAWS OF MINNESOTA, 1959 SESSEON, AND AMENDMENTS.

The City of Mankato, Minnesota does ordain:

Section 1.

A petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Ralph Haefner and Della M. Haefner, husband and wife, Terrance Haefner, unmarried, and Clement W. Scheurer and Anastasia M. Scheurer, his wife, as sole owners of the following described real estate, to have such land included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

All that portion of the Northwest Quarter of the Northwest Quarter of Section 16, Township 108 North, of Range 26, described as follows:

Beginning at a point 305.70 feet due East of Holly Lane and 120 feet due North of Sunray Avenue, thence due North 511.80 feet, thence 304 feet due West to Holly Lane, thence due North 66 feet on the East line of Holly Lane, thence due East 353.70 feet, thence due South 242.00 feet, thence due East 153 feet, thence due South 420.55 feet, thence due West 203 feet to the point of beginning.

Section 3.

The City Council of Mankato, Minnesota hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tract and parcel of land is so conditioned as properly to be subjected to city govornment and is hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Connission, the County Auditor, and the Secretary of State, and this ordinance takes effect ten (10) days after its passage and publication and upon the filing of certified copies, as herein described.
