AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF WASECA, MINNESOTA.  
THE COMMON COUNCIL OF THE CITY OF WASECA DO ORDAIN:

SECTION 1. WHEREAS, the below described property is completely surrounded by land within the Municipal limits of the City of Waseca and has been so surrounded for a space of time in excess of 10 years, said property lying and being in the County of Waseca and State of Minnesota, described as follows, viz:

The East One-Half ( $E\frac{1}{2}$ ) of Lot Twelve (12) of Wards Subdivision "A" to the City of Waseca, according to the Plat thereof on file and of record in the office of the Register of Deeds in and for said County and State, together with the West One-Half ( $W\frac{1}{2}$ ) of Fourth Street Southwest contiguous to the East line of the aforesaid East One-Half ( $E\frac{1}{2}$ ) of Lot Twelve (12).

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WASECA, MINNESOTA, pursuant to the authority and provisions of Section 414.08, Subdivision 2, Minnesota Statutes Annotated:

SECTION 2. That the said real estate described hereinbefore is deemed to be urban in character and that it be, and the same hereby is, annexed to the City of Waseca, Minnesota.

SECTION 3. That a duly certified copy of this Ordinance shall be filed with the Minnesota Municipalities Commission, the Waseca County Auditor, the Secretary of the State of Minnesota, and that a certified copy of this Ordinance shall be filed and recorded in the office of the Register of Deeds of Waseca, Minnesota.

SECTION 4. This Ordinance shall take effect and be in force from and after its publication in accordance with law.
