327 CHAPTER NO.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN PLATTED LANDS.

WHEREAS, on the 31st day of October, 1963 there was filed with the City Council of the City of Montevideo, Minnesota, a Petition requesting that the corporate limits of the City of Montevideo be extended to embrace the hereinafter described platted tract of land lying within the County of Chippeva, State of Minnesota, to-wit:

> The West Half of Sublot Fourteen (VI/s SL 14) in Ira B. Wolfe Subdivision into Sublets Seven (7) through Seventeen (17) in the Southeast Quarter of the Southeast Quarter (SE 1/4 SE 1/4) of Section Seven (7) in Township One Hundred Seventeen (117) Range Forty (40), Chippeva County, Minnesota, according to the duly recorded Plat thereof on file and of record in the Office of the Register of Deeds in and for Chippeva County, Minnesota, containing 0.41 acres.

WHEREAS, a copy of said Petition was mailed to the Town Board of Sparta, the Board of County Commissioners of the County of Chippewa and the Minnesota Municipal Commission on the 1st day of November, 1963 and no objections having been filed by any of said bodies with the City Council of the City of Montevideo, and

WHEREAS, the City Council having determined and does hereby determine that the annexation of said platted tract of land to the City of Montevideo will be to the best interests of said City and of the territory affected, and.

WHEREAS, the hereinbefore described tract of land abuts upon land now within the corporate limits of the City of Montevideo, and is so conditioned as to be properly subject to municipal government and control,

NOW, THEREFORE, The City of Montevideo does hereby ordain as follows:

SECTION 1. That the property hereinbefore described be and the same hereby is annexed to and included in the City of Montevideo, Minnesota as effectively as if it had originally been part thereof.

SECTION 2. This Ordinance shall be final and shall take effect on its passage and publication as by the Charter provided and be in force from and after the filing of the certified copy thereof with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and the Register of Deeds of Chippeva County, Minnesota.

## STIPULATION

WHEREAS Chapter No. 327 of the Ordinance of the City of Montevideo being an Ordinance extending the corporate limits of the City of Montevideo, Minnesota to include certain platted lands inadvertently described the lands to be annexed as being located in Section Seven (7), Township One Hundred Seventeen (117), Range Forty (40) in Chippewa County, Minnesota
