

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF HUTCHINSON,

MCLEOD COUNTY, MINNESOTA.

The City Council of the City of Hutchinson ordains:

SECTION I.

WHEREAS, the City of Hutchinson is the owner of the following described lands lying and being in the County of McLeod and State of Minnesota and described as follows, to-wit:

Beginning at the Southeast corner of Lot 12 of Auditor's Plat of South Half (S $\frac{1}{2}$ ), Section Thirty (30) and North Half (N $\frac{1}{2}$ ), Section Thirty-one (31), Township One Hundred Seventeen (117) North, Range Twenty-nine (29) West, McLeod County, Minnesota, according to plat on file in the Register of Deeds Office of said County and State; thence West along the South line of said Lot 12, 650.80 feet; thence deflect right at an angle of 91°34' a distance of 293.00 feet; thence deflect left at an angle of 91°34' along a line parallel with the South line of said Lot 12 a distance of 487.60 feet; thence deflect right at an angle of 89°47' a distance of 358.75 feet to the North line of said Lot 12; thence deflect right at an angle of 90°13' and along said North line of said Lot 12 a distance of 1149.57 feet to the Northeast corner of said Lot 12; thence deflect right at an angle of 91°34' and along the East line of said Lot 12, 651.90 feet to the point of beginning, tract containing 13.26 acres.

SECTION II.

AND WHEREAS, said above described land is contiguous to and abutts upon the City Limits of the City of Hutchinson.

SECTION III.

AND WHEREAS, the City Council of the City of Hutchinson deems it desirable and in the best interest of the City of Hutchinson to annex the above described lands to the City of Hutchinson.

SECTION IV.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hutchinson that the lands described above be and they hereby are annexed to the City of Hutchinson and from and after the date of passage of this Ordinance, said lands shall become a part and portion of the City of Hutchinson with the same force and effect as though originally a part of the City.

SECTION V.

This Ordinance shall take effect and be in force from and after its publication.
