

ORDINANCE NO. 512

AN ORDINANCE ANNECKING CERTAIN TERRITORY TO AND EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF FAIRMONT, MINNESOTA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FAIRMONT, MINNESOTA, AS FOLLOWS:

Section 1. That a petition presented to the City Council of the City of Fairmont, Minnesota, requesting that property hereinafter described be annexed to the City of Fairmont, has been signed by Loyal O. Bacon and Elaine Bacon wife; Carroll L. Bacon and Luella H. Bacon, his wife; Wilbur M. Bacon and Marie Bacon, his wife; Daryl H. Kolumpus and Clara M. Kolumpus, his wife, the owners of said property; that the said property abuts upon the corporate limits of the City of Fairmont, Minnesota; that it is so conditioned to be properly subject to municipal government; that the unplatte part thereof does not exceed two hundred (200) acres in area; that the annexation will be to the best interest of the municipality and the territory affected; that said petition is in accordance with M. S. A. Section 414.03 and is in all things sufficient; that said petition has been on file with the Martin County Board of Commissioners, the Town Board of Fairmont Township, and the Municipal Commission of the State of Minnesota for a period of not less than 30 days in accordance with Law and that no written objections to said petition have been submitted.

Section 2. That the property set forth in said petition is located in the County of Martin, State of Minnesota, and described as follows, to-wit:

All that part of Government Lot Three (3) of Section Seventeen (17), Township One Hundred Two (102) North of Range Thirty (30) West of the Fifth Principal Meridian, bounded by lines as follows, to-wit: Starting at a point One Hundred Sixty-Five (165) feet West of the center of the said Section Seventeen (17) run thence West fifty (50) feet; thence South at right angles One Hundred Eighty-three (183) feet; thence East Fifty (50) feet; thence North One Hundred Eighty-three (183) feet to the place of beginning, containing twenty-one hundredths (.21) acres, be the same more or less;

and that the said property be, and the same hereby is, extended to and incorporated within the corporate limits of the City of Fairmont, Minnesota, and is hereby

declared to be a part of the City of Fairmont, Minnesota, as effectually as if  
the same had been originally a part thereof and that the corporate limits be and  
the same hereby are extended to include said property.

Section 3. That this ordinance shall be in force and effect from  
and after its passage and publication and the filing of a certified copy with  
the Municipal Commission, the County Auditor, and the Secretary of State as  
required by law. In addition the City Clerk is hereby directed to file a  
certified copy of this ordinance in the office of the Register of Deeds for  
Martin County, Minnesota.
