ORDINANCE #576

AN ORDINANCE TO ANNEX CERTAIN LANDS IN AND TO  
THE CITY OF INTERNATIONAL FALLS, MINNESOTA,  
AND DECLARING SAME TO BE AN EMERGENCY ORDINANCE.

The City Council of the City of International Falls, Minnesota, do ordain as follows:

Section I. A petition having been filed with the Council of the City of International Falls, by all the owners of the following described tract of land to-wit:

That part of the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$  SE $\frac{1}{4}$ ),  
Section Thirty-three (33), Township Seventy-one (71), Range Twenty-four (24),  
situated in the County of Koochiching and contained within the following metes  
and bounds:

Beginning at the southwest corner of the plot of Parkway  
Addition, Blocks One (1) and Two (2), thence south along  
the extension of the west line of 15th Avenue in the said  
plot, a distance of 352.37 feet, thence angling east  
34 $^{\circ}$ -34'-05", a distance of 336.60 feet to a point on the  
south line of said SW $\frac{1}{4}$  SE $\frac{1}{4}$  404.43 feet west of the south-  
east corner of said SW $\frac{1}{4}$  SE $\frac{1}{4}$ , thence east to the southeast  
corner of said SW $\frac{1}{4}$  SE $\frac{1}{4}$ , thence north 630.04 feet along  
the east side of said SW $\frac{1}{4}$  SE $\frac{1}{4}$  to the south line of 13th  
street in said plat, thence west along the south line of  
said 13th street 602.37 feet to the point of beginning.

Section II. That after due consideration of the said aforementioned petition,  
the City Council deems it to be to the best interest of said City of International  
Falls, that said lands be annexed to and become a part of said City.

Section III. That accordingly, the petition of said owner be and is hereby approv-  
ed and said lands be and they hereby are annexed to the City of International Falls,  
and said lands hereby are a part of and subject to the jurisdiction of said City  
of International Falls.

Section IV. This is an emergency ordinance in the immediate interests of the  
public health, safety, welfare, peace and good order of the citizens of the City,  
and shall take effect and be in force from and after its passage, approval and  
publication.
