ANNEXATION OF LAND IN HOLLOWAY ADDITION

In the Village of Hills, a petition signed by Arnold F. Mueller, Ruth A. Mueller, Arnold F. Mueller and Ruth A. Mueller has been filed with the Village Clerk and has now been read and considered by the Village Council of Hills, Minnesota, and,

Whereas, said petition is for the annexation of certain unplatated land not exceeding two hundred (200) acres in area and owned by all of the owners thereof, their spouses joining therein, said premises being hereinafter described: THE VILLAGE OF HILLS, ROCK COUNTY, MINNESOTA, WISCONSIN.

1. That it would be to the best interests of this Village, and the territory affected, to annex the following described premises:

Commencing at the northeast corner of Section Twenty-eight (28), Township One hundred One (101) North, Range Forty-six (46) West, County of Rock, State of Minnesota, thence southerly on the east line of said Section to a point 80.00' south of the south line of Block Twenty-nine (29), Holgeson and Mueller Addition to the Village of Hills, which point is the south line of Fourth Street, thence westerly for 50.00' to the west line of the right of way of Rock County State Aid Highway Number Six (6), which point is the true beginning, thence westerly on the south line of Fourth Street for 604.42', thence southerly on a line parallel to Central Avenue in the Village of Hills for 356.00', thence easterly on a line parallel to Fourth Street to the east line of the right of way of said C.A.H. Number Six, thence northerly 356.00' to the true point of beginning.

2. That the above described premises should be, and are hereby declared, annexed to the Village of Hills.

3. That the Village Clerk is hereby authorized and directed to file a copy of this ordinance with the Corporation having jurisdiction, the County Auditor of Rock County and the Secretary of State of the State of Minnesota.
