## CHAPTER NO. 312

AN ORDINANCE TO ANNEX A CERTAIN TRACT OF LAND TO THE CITY OF MONTEVIDEO AND DECLARING SAID TRACT OF LAND TO BE AN ADDITION TO AND A PART OF THE CITY OF MONTEVIDED, MINNESOTA

WHEREAS a Petition has been filed with the City Council of the City of Montevideo, Minnesota, by the sole owner in fee of the following described tract of land lying and being in the County of Chippewa, State of Minnesota, to-wit:

A Parcel of land in the Southwest Quarter (SW 1/4) of Section Eight (8), Township One Hundred Seventeen North (117N), Range Forty West (40W) of the Fifth Principal Meridian designated as Block One (1) of Kohr's First Addition according to the Plat thereof on file and of record in the Office of the Register of Deeds in and for Chippewa County, Minnesota,

praying that the said tract of land be annexed to and made a part of the City of Montevideo, Minnesota and extending the corporate limits of said City to include said platted tract of land, and

WHEHEAS it appears that said tract of land abuts upon the incorporated City of Montevideo and the City Council hereby determines that
said Petitioner is the sole owner in fee thereof; that said tract of land is
so located as to be properly subject to annexation to the City of Montevideo
and is suitable and adaptable to municipal purposes and municipal regulations, government and control,

The City Council of the City of Montevideo hereby determines that the annexation will be to the best interests of the City of Montevideo and of the territory affected.

That the quantity of land embraced within the foregoing description and bounded as described is 12.1 acres.

NOW THEREFORE, the City of Montevideo does ordain as follows:

1. That the property hereinbefore described be and the same is hereby annexed to and included in the City of Montevideo, Minnesota as effectually as if it has been originally a part thereof.

This Ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal

Commission, the County Auditor and the Secretary of State and from and after its passage and publication as by the Charter provided.
