
ORDINANCE No. 1253

AN ORDINANCE Annexing to the City of Rochester, Minntesota, Certain Unplated Land. Not Exceeding Two "Hundred Acres in Area, All Beling in the Sculficest Quarter of Section Thirty-four, Township One Hundred Seven North, Range Fourteen West, Olmsted County, Minnesota.

The Common Council of the City of Rochester do ordain:
Section 1. The City of Rochester is the owner of the following described land in Olmsted County, Minnesota:
Commencing at a point which is 330.0 feet south of the North line of the Southeast Quarter (SE 1/4) of Section 34, Township 107 North, Range 14 West, and 422.6 feet west of the east line of the Southeast Quarter (SE 1/4) of Section 34, Township 107 North, Range 14 West for a place of beginning; thence running west along the north line of Cascade Plaza a distance of 185.0 feet to the Southeast corner of Lof 3, Cascade Center, a distance of 185.0 feet to the Southeast corner of Lof 3, Cascade Center, a distance of 50.57 feet; thence northwesterly along the south right-of-way line of Fifth Street Northwest on a curve defined as follows:
