The Municipal Commission acknowledges receipt of your Ordinance No. 100 and filing fee in accordance with Minnesota Statutes 414.03, Chapter 807, Section 8 and the Commission's Amended Rules of Procedure. The ordinance was accepted for filing on April 24, 1964.

This is in reply to your letter to me of April 24th concerning Ordinance No. 100 of the Village of Twin Valley.

In your letter, you pointed out that, according to the surveyor's map which I filed with the ordinance, the North-South figure should be 436 feet instead of 431 feet. I took this matter up with the County Surveyor, who drew the map and also helped me with the worded description. The surveyor informed me that the description in the Ordinance is correct and that the map was in error. It was our intention to take in all of the land that the Village owned and the description in the ordinance does this. The surveyor tells me that he made this error on his map because he originally showed a proposed 70 foot street and ran the North-South line all the way to the North edge of it, whereas he should have stopped 5 feet short thereof.

Therefore, as I stated, the description in the ordinance is correct and the map should actually have shown a distance of 431 feet.

ORDINANCE NO. 100

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF TWIN VALLEY TO INCLUDE CERTAIN UNPLETTED LANDS OWNED BY THE VILLAGE, HEREIN DESCRIBED, LOCATED IN THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER (NE1/4NE1/4) OF SECTION TWENTY-EIGHT (28), TOWNSHIP, NORMAN COUNTY, MINNESOTA.

Section 1. DECLARATION. It is hereby determined that the hereinafter described property is unpletted; that the same abuts on the Village limits of the Village of Twin Valley; that said property is owned by the Village of Twin Valley; and that said territory is so conditioned as to be properly subjected to Village government, and the annexation thereof will be in the best interests of the Village and the territory affected.

Section 2. TERRITORY ANNEXED. The corporate limits of the Village of Twin Valley are hereby extended to include the territory described as follows:

Commencing at the Southwest corner of the Northeast Quarter of the Northeast Quarter (NE1/4NE1/4) in Section Twenty-eight (28), Township One Hundred Forty-four (144), Range Forty-four (44); thence East Five Hundred Fifty-six (556) feet on the South boundary line of said Northeast Quarter Northeast Quarter (NE1/4NE1/4) in Section Twenty-eight (28), thence North Four Hundred Thirty-one (431) feet parallel to the East boundary line of said Section Twenty-eight (28), thence East Seventy-five (75) feet parallel to the North boundary line of said Section Twenty-eight (28), thence North parallel to the East boundary line of said Section Twenty-eight (28) to the Southwest boundary line of the right-of-way of Trunk Highway Thirty-two (32), thence Northwest following the Southwest boundary line of the right-of-way of Trunk Highway Thirty-two (32) to the West boundary line of said Northeast Quarter Northeast Quarter (NE1/4NE1/4) in Section Twenty-eight (28), thence South on the West boundary line of said Northeast Quarter Northeast Quarter (NE1/4NE1/4) in Section Twenty-eight (28) to the place of beginning.

Section 3. FILING. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the Norman County Auditor.

Section 4. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its publication and the filing of the certified copies as directed herein.
