ORDINANCE NO. 42

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SHELLY TO INCLUDE CERTAIN UNPLATTED LANDS OWNED BY THE VILLAGE, HERIN DESCRIBED, LOCATED IN THE NORTHEAST QUARTER OF THE NORTHEAST QUADRANT (NE1/4) OF SECTION NINETEEN (19), SHELLY TOWNSHIP, NORMAN COUNTY, MINNESOTA.

Section 1. DECLARATION. It is hereby determined that the hereinafter described property is unplatated; that the same abuts on the Village limits of the Village of Shelly; that said property is owned by the Village of Shelly; and that said territory is so conditioned as to be properly subjected to Village government, and the annexation thereof will be in the best interests of the Village and the territory affected.

Section 2. TERRITORY ANNEXED. The corporate limits of the Village of Shelly are hereby extended to include the territory described as follows:

Commencing at the Northwest Corner of Section Nineteen (19), Township One Hundred Forty-six (146), Range Forty-eight (48), Norman County, Minnesota; thence West on the Section Line a distance of 241.71 feet; thence Southerly, parallel with the East line of said Section Nineteen (19), a distance of 241.71 feet; thence Northerly, parallel with the North line of said Section Nineteen (19), a distance of 241.71 feet to the East line of said Section; thence Northerly on the Section Line 241.71 feet to the place of beginning.

Section 3. FILING. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the Norman County Auditor.

Section 4. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its publication and the filing of the certified copies as directed herein.
