PETITION

To the Village Council of the Village of Sauk Rapids, County of Benton, State of Minnesota: The undersigned who are a majority of the owners of the lots and parcels of ground, a description of which is set opposite our respective names, and where it is proposed to annex to said Village, do hereby petition your honorable body to annex said property as follows, viz:

That part of NW<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub> of Section 23-36-31 described as follows:

Beginning at a point on South line of said NW<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub>, said line being also present North Village limits of Sauk Rapids, said point being 416.98 feet East of SW corner of said NW<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub>; thence NW<sup>1</sup>/<sub>4</sub>ly on NE<sup>1</sup>/<sub>4</sub>ly right-of-way line of a platted alley 170.27 feet to South right-of-way line of 9<sup>1</sup>/<sub>2</sub> Street North; thence East on said South right-of-way line 298.93 feet to East right-of-way line of a platted alley extended Southerly; thence North on said extended alley right-of-way line 66.04 feet; thence deflect left 91°04'12" a distance of 233.9 feet; thence South 208.86 feet to a point on South line of NW<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub> which point is 401.84 feet East of point of beginning; thence West on said line to point of beginning.

And we do request your honorable body to adopt a resolution ordering the said property to be annexed as set forth herein and in accordance with the statute in such case made and provided.

ORDINANCE NO. 190

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SAUK RAPIDS TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

Section 15:35 (1) A petition has been filed with the governing body of the Village of Sauk Rapids, Minnesota, by the sole owner or all of the owners in number of the following described real estate to have such land included in the Village of Sauk Rapids:

All that part of the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ), Section 23, Township 36 North, Range 31 West described as follows:

Commencing at the Southwest corner of said Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ); thence East 416.98 feet on the South line thereof to the Northeastly right-of-way line in the alley in Block Forty-five (45), Wood Russell and Gilman's Addition extended Northwestly; thence North 45° 07' 48" West on said right-of-way line extended 178.27 feet to South right-of-way line of 9 $\frac{1}{2}$  Street North; thence North 87° 19' East of said right-of-way line 298.93 feet; thence North 66.04 feet; thence South 88° 55' 48" East a distance of 233.9 feet; thence South 1° 04' 12" West; 208.86 feet to the South line of the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of said Section; thence West on said South line to the point of beginning.

(2) The quantity of land embraced in the foregoing description, and bounded as described, is 1 1/2 acres.


(3) Notice of this proposed annexation was given to the Township of Sauk Rapids, County of Benton, and to the Minnesota Municipal Commission more than 30 days previous.

(4) The Village Council hereby determines (1) that the annexation will be to the best interests of the Village of Sauk Rapids, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the Village of Sauk Rapids and is so conditioned as properly to be subjected to Village government.


(5) Therefore, the Village of Sauk Rapids, Minnesota, hereby ordains and declares that the property hereinbefore described by and the same is hereby annexed to, and included in, the Village of Sauk Rapids, Minnesota, as effectually as if it had originally been a part thereof.

(6) This ordinance shall be final and shall take effect and be in force from and after filing Certified copy thereof with the Minnesota Municipal Commission, and the County Auditor, and the Secretary of State, and from and after its passage and publication.


