## ORDINANCE NO. 190

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VITLAGE OF SAUK RAPIDS TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING THE UNDRID ACRES.

Section 15:35 (1) A potition has been filed with the governing body of the Village of Sauk Rapids, Minnesota, by the sole owner or all of the owners in number of the following described real estate to have such land included in the Village of Sauk Rapids:

All that part of the Northwest Cuarter of the Northwest Quarter (NW; of NW;), Section 23, Township 36 North, Range 31 West described as follows:
