ORDINANCE NO. 1964-1

An Ordinance extending the Corporate Limits of the City of Paynesville, a Municipal Corporation of the State of Minnesota to include certain land not exceeding 200 acres.

Be it ordained by the Village of Paynesville as follows:

Section I. Petition, Whereas, a petition has been filed with the governing body of the Village of Paynesville, a municipal corporation of the State of Minnesota by the sole owner and all persons having any interest therein, to have certain real property, hereinafter described included within the City of Paynesville, Minnesota, and

WHEREAS, it is proposed to annex by virtue hereof to the said Village of Paynesville, said property, all of which is in Stearns County, in said State, and

Section II. Land Embraced. The quantity of land embraced within the following description is approximate 9 acres and,

Whereas, the said property is described as follows, to-wit:

The West Forty-nine (49) rods of the Northwest Quarter of the Southwest Quarter (NW<sub>1/4</sub>, SW<sub>1/4</sub>), less the West Twenty-two and one half (22½) rods thereof, of the section Numbered Sixteen (16), in Township 122, North of Range Thirty-two (32) West of the Fifth Principal Meridian, in Stearns County, Minnesota, excepting therefrom all the land lying Southwesterly of the center line of trunk highway #55, which trunk highway intersects the above described tract.

Now, Therefore, the Village Council of the Village of Paynesville hereby determines, ordains and declares as follows:

-1-

That the annexation will be to the best interest of the Village of Paynesville, Minnesota, and of the territory affected.

-2-

That the property above described abuts upon the Village and is so conditioned as property to be subject to City government.

-3-

That said property is hereby annexed and included within the City of Paynesville, Minnesota, as effectually as if it had originally been a part hereof.

Section III. Effective Date. This Ordinance shall be final and shall take effect and be in full force from and after filing a

certified copy hereof with the Minnesota Municipal Commission, the County Auditor of the County of Stearns, Minnesota, and the Secretary of State of Minnesota and from and after its passage and publication.

Section IV. This Ordinance shall take effect and be in force from and after its publication.
