

ORDANANCE NO. 51

AN ORDINANCE ANNEXING CERTAIN TERRITORIES OF THE VILLAGE OF RAYMOND AND DECLARING THE SAME TO BE AN ADDITION TO SAID VILLAGE.

BE IT ORDAINED FOR THE VILLAGE OF RAYMOND AS FOLLOWS:

SECTION I. A Petition has been filed with the Village Council of the Village of Raymond, Minnesota, by the owners of the following described real estate to have such land included within the Village of Raymond as follows:

Church of the Sacred Heart: Commencing at the Northeast corner of the Southeast Quarter, Section 19, Township 118, Range 36, thence running due West 978 feet, thence due South 417.4 feet, thence due East 978 feet, thence due North 417.4 feet to the point of beginning.

Clarence L. Gunter and Dorothy M. Gunter, husband and wife and Richard E. Fitzsimmons and Lenore Fitzsimmons, husband and wife; Part of the Southeast Quarter of Section 19, Township 118, Range 36, described by notes and bounds as follows: Beginning at a point which is 978 feet West and 39.6 feet South of the Northeast corner of said Southeast Quarter; thence due West 201.6 feet; thence South 140 feet, thence East 208.6 feet, thence North 140 feet, to the place of beginning.

Ronald Ronning and Jane Ronning, husband and wife; Lot 7, Holtz's Addition in Edwards Township.

Orlo C. Almlie and Helen M. Almlie, husband and wife; Lot 5, Holtz's Addition in Edwards Township.

SECTION II. That the Village Council makes the following determination

as to -WIT:

1. That the Annexation will be to the best interest to the Village of Raymond, Minnesota and of the Territory affected.
2. That the Territory described herein abuts upon and is adjacent to the Village of Raymond, Minnesota and is so conditioned as properly to be subject to the Government of said Village.

SECTION III. Therefore, the Village of Raymond, hereby ordinances and declares the property hereinbefore described be and the same hereby is annexed to and included in the Village of Raymond, Minnesota.

SECTION IV. This Ordinance shall be final and should take effect and be in full force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the County Auditor of Kandiyohi County and the Secretary of State of the State of Minnesota.






