

ORDINANCE NO. 123

An Ordinance annexing certain lands to the Village of Olivia.

The Village Council of the Village of Olivia does ordain as follows:

Section 1 - The following described property abutting upon the incorporated Village of Olivia is hereby annexed to the Village of Olivia and shall become a part of such village as effectually and for such purposes as if it had originally been a part thereof:

The South 150 feet of the North 132½ feet of the West 64 rods of the Northwest Quarter of the Southeast Quarter, Section 18, Township 115, Range 34, according to the U. S. Government survey thereof.

Section 2 - This Ordinance shall be in full force and effect from and after the date of its publication.

Passed by the Village Council this 18 day of August, 1964.

RESOLUTION

At a duly called and held meeting of the Village Council of the Village of Olivia, Minnesota, the matter of annexation of land came up for discussion. From the information available to the Council and upon the verified petition of Andrew R. Johnson, Jr. of Olivia, Minnesota, sole owner of the hereinafter described property, it appears that the real estate is properly conditioned so as to be subjected to and benefited by municipal government and that the annexation as proposed will be to the best interests of the owner of said real estate and to the Village of Olivia.

After discussion of said matter, Councilman M. S. Nelson

proposed the following resolution and moved its adoption, to-wit:

WHEREAS, the sole owner of lands abutting upon the Village of Olivia, has petitioned for the annexation of said lands to the incorporated Village of Olivia, and

WHEREAS, no written objections have been interposed to said annexation by the County Board of the County of Renville, or the Town Board of the Town of Bird Island, and there are no written objections on file with the Village Clerk or the Minnesota Municipal Commission, and

WHEREAS, said lands are unplatted and are described as:

The South 150 feet of the North 182½ feet of the West 64 rods of the Northwest Quarter of the Southeast Quarter, Section 18, Township 115, Range 34, according to the U. S. Government survey thereof; and

WHEREAS, said real estate is properly conditioned for administration by Municipal Government and it will be to the best interest of the Village of Olivia and to the owner of said lands that said real estate be annexed to the Village of Olivia.

NOW THEREFORE, be it resolved by the Village Council of the Village of Olivia, Renville County, Minnesota that the attached Petition be granted and the real estate therein described and above described, be and the same hereby is annexed to the corporate

limits of the Village of Olivia, DeWitt County, Minnesota
to the same effect and for all purposes as though it had been
originally a part of said village.

Councilman Ben Dirks seconded

the motion for the adoption of such Resolution and upon submission
thereof, said Resolution was declared duly adopted.
