## ORDINANCE NO. 261

AM ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF HUTCHINSON, MCLEOD COUNTY, MINNESOTA.

The City Council of the City of Hutchinson ordains:

WHEREAS, Earl Hansen and Lydia Hansen are the true and only owners of the following described lands lying and being in the County of McLeod and State of Minnesota and described as follows to-wit:
