

EXECUTIVE ORDER NO. 13

WHEREAS, the Library Services and Construction Law (Public Law 597, 84th Congress, as subsequently amended) makes funds available to the State of Minnesota for the development of public library services and the construction of public library facilities; and

WHEREAS, The State Board of Education at its regular meeting has adopted the necessary plans for operating the programs involved in implementing the act; pending review by the Attorney General and acceptance by the Governor; and


WHEREAS, The Office of the Attorney General has certified that such plans are consistent with law; and

WHEREAS, Minnesota Statutes, Chapter 124, Section 62, provides that in the event of the passage of such legislation and upon recommendation of the State Board of Education, at a time when the legislature is not in session, the Governor shall accept the provisions of such act by executive order pending further action by the legislature;


