

ORDINANCE NO. 9.01

AN ORDINANCE FOR THE ANNEXATION OF  
CERTAIN TERRITORY OWNED BY THE  
VILLAGE OF MOTLEY, MINNESOTA, AND  
ABUTTING ON SAID VILLAGE

The Village Council of the Village of Motley ordains:

Section 1. That that certain territory described as  
follows, to-wit:

The fractional Southeast Quarter of Southwest  
Quarter (SE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) or Lot Thirteen (13), the  
Southwest Quarter of Southeast Quarter (SW $\frac{1}{4}$  of  
SE $\frac{1}{4}$ ) of Section Seven (7), and the fractional  
Northwest Quarter of Northeast Quarter (NW $\frac{1}{4}$  of  
NE $\frac{1}{4}$ ) or Lot Two (2) of Section Eighteen (18),  
all in Township One Hundred Thirty-three (133),  
North of Range Thirty-one (31) West of the Fifth  
Principal Meridian, containing 111.46 acres, more  
or less, according to the United States Govern-  
ment survey thereof, less roadways or right of way  
previously retained or deeded and subject to  
reservations and easements of record, Cass County,  
Minnesota,

being owned by said Village and abutting upon the same and not  
included in any other municipality, is hereby declared to be  
annexed to and included within the said Village of Motley.

Section 2. This ordinance shall take effect and be in  
force and effect from and after its publication.
