

ORDINANCE NO. 191

PARAGRAPH NO. 1 OF ORDINANCE NO. 187 OF THE VILLAGE OF SAUK RAPIDS IS HEREBY AMENDED TO READ AS FOLLOWS:

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SAUK RAPIDS TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCLUDING TWO HUNDRED ACRES.

Section 15:33 (1) The governing body of the Village of Sauk Rapids, Minnesota, resolves to have the following land included within the Village of Sauk Rapids, Minnesota:

The Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$) of Section 22, Township 36, Range 31 and that part of the Northwest Quarter of Section 23, Township 36 North, Range 31 West lying Westerly of Larson's Addition and of the West line of Larson's Addition extended to the North; and the Westerly Thirty-three (33) feet of the South One-Half of the Southwest Quarter of the Southwest Quarter of Section Fourteen (14), Township Thirty-six (36) North, Range Thirty-one (31) West, all being in Benton County, Minnesota.

This amendment shall be final and shall take effect and be in force from and after filing Certified copy with the Minnesota Municipal Commission, the Benton County Auditor, and the Minnesota Secretary of State, and from and after its passage and publication.

ORDINANCE NO. 197

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SAUK RAPIDS TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

Section 15:33 (1) The governing body of the Village of Sauk Rapids Minnesota, resolves to have the following land included within the Village of Sauk Rapids, Minnesota:

The Northeast Quarter of the North Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section 22, Twp. 36, Range 31 and that part of the Northwest Quarter (NW $\frac{1}{4}$) of Section 23, Twp. 36 North, Range 31 West lying Westerly of Larson's Addition and of the West line of Larson's Addition extended to the North, Fenton County, Minnesota.


(2) The quantity of land embraced within the foregoing description, and bounded as described, is 42 acres.

(3) The Village Council hereby determines (1) that the annexation will be to the best interests of the Village of Sauk Rapids, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village government; (3) that the territory is completely surrounded by said Village.


(4) Therefore, the Village of Sauk Rapids, Minnesota, hereby ordains and declares that the property herein before described by and the same is hereby annexed to, and included in, the Village of Sauk Rapids, Minnesota, as effectually as if it had originally been a part thereof.

(5) This ordinance shall be final and shall take effect and be in force from and after filing Certified copy thereof with the Minnesota Municipal Commission, the County Auditor and Secretary of State, from and after its passage and publication.
