ORDINANCE NO. 171

An Ordinance Amending Lot 6, Block 10,
Lakewood Addition, to the Village of
Mankato.

THE VILLAGE BOARD OF THE VILLAGE OF MANKATO DO HEREBY AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all
of the owners of the land hereinafter described, in Washington County,
Minnesota, containing less than two hundred acres, abutting on the
Easterly side of the Village of Mankato, requesting the annexation
of said land to said Village, said Petition having been duly filed with
the Clerk of said Village; and it appearing that such annexation will be
to the best interests of the Village and of the territory affected, the
Village boundaries of the Village of Mankato are hereby extended to
include said land described as follows:

Lot 6, Block 10, Lakewood Addition

and that said territory is hereby made a part of the Village of Mankato
as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the
filing of a certified copy thereof with the County Auditor of Washington
County and the Secretary of State of the State of Minnesota and with the
Minnesota Municipal Commission and from and after its publication.
