ORDINANCE NO. 171

An Ordinance Annexing Lot 6, Block 10,
Lakeview Addition, to the Village of
Nahto-nedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF NAHTO-NEDI DO ORDEAWEAS

Section 1. That pursuant to that certain petition signed by all
of the owners of the land hereinbefore described, in Washington County,
Minnesota, containing less than two hundred acres, abutting on the
Easterly side of the Village of Nahto-nedi, requesting the annexation
of said land to said Village, said Petition having been duly filed with
the Clerk of said Village; and it appearing that such annexation will be
to the best interests of the Village and of the territory affected, the
Village boundaries of the Village of Nahto-nedi are hereby extended to
include said land described as follows:

Lot 6, Block 10, Lakeview addition

and that said territory is hereby made a part of the Village of Nahto-nedi
as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the
filing of a certified copy thereof with the County Auditor of Washington
County and the Secretary of State of the State of Minnesota and with the
Minnesota Municipal Commission and from and after its publication.


