An ordinance extending the corporate limits of the City of Willmar, a Municipal Corporation of the State of Minnesota to include certain land not exceeding 200 acres.

Be it ordained by the City of Willmar as follows:

SECTION I. Petition. Whereas, a Petition has been filed with the governing body of the City of Willmar, a Municipal Corporation of the State of Minnesota by the sole owners and all persons having any interest therein, to have certain real property, hereinafter described included within the City of Willmar, Minnesota and Whereas, it is proposed to annex by virtue hereof to the said City of Willmar, said property, all of which is in Kandiyohi County in said State, and

SECTION III. Effective Date. This Ordinance shall be final and shall take effect and be in full force from and after filing a certified copy hereof with the Minnesota Municipal Commission, the County Auditor of the County of Kandiyohi, Minnesota, the Town Clerk of the Township of Willmar, and the Secretary of State of Minnesota, and from and after its passage and publication.

SECTION IV. This Ordinance shall take effect and be in force from and after its publication.
