OFFICIAL PUBLICATION
ORDINANCE NO. A 326
AN ORDINANCE ANNEXING AND MAKING CERTAIN REAL ES-
TATE A PART OF THE CITY OF FARIBAULT.

WHEREAS, the Faribault Industrial Corporation, a Minnesota corporation, is the owner of certain unplatted land abutting on the City of Faribault, Minnesota, not included in any other municipality and containing less than two hundred acres in area; and

WHEREAS, said owner has petitioned to have such land annexed to the City; and

WHEREAS, it is and will be to the best interests of the municipality and of the territory affected if the property is annexed; NOW THEREFORE —

THE COUNCIL OF THE CITY OF FARIBAULT DO ORDAIN:

Section 1. That the following described unplatted real estate situated in Rice County, Minnesota, containing not more than twenty-six acres of area abutting on the City of Faribault, Minnesota, not contained within any other municipality, and being wholly owned by Faribault Industrial Corporation, a Minnesota corporation, is hereby annexed to the municipality of the City of Faribault, Minnesota:

All that part of the South One Half (S½) of the Northeast Quarter (NE¼) of Section 19, Township 110 North of Range 20 West of the Fifth Principal Meridian, which lies West of the right-of-way of the Chicago, Great Western Railway Company and East of an area taken by condemnation by the State of Minnesota for highway purposes and State Trunk Highway 218 (S.T.H. 3) and also all that part of the North Quarter (N¼) of the North One Half (N½) of the Southeast Quarter (SE¼) of said Section 19, Township 110 North of Range 20 West which lies West of the right-of-way of Chicago, Great Western Railway Company and East of said area taken by condemnation by the State of Minnesota.

Section 2. This ordinance shall take effect and be in force ten (10) days from and after its passage and publication.




