ORDINANCE ADOPTED BY THE VILLAGE OF FORTILL, MONTANA

AN ORDINANCE AMENDING AN ORDINANCE ENACTING THE CORPORATE LIMITS OF THE VILLAGE OF FORTILL TO INCLUDE CERTAIN UNINCORPORATED UNPLANTED LAND NOT EXCEEDING 200 ACRES IN AREA ADJACENT UPON THE VILLAGE LIMITS.

WHEREAS the Village Council of the Village of Fortill did adopt the above Ordinance on the 16th day of March, 1954; and,

WHEREAS said ordinance was duly published in the Times Publishing Co., a daily newspaper on the 17th day of June, 1954; and,

WHEREAS it now appears that the legal description of the tract thereby annexed was incorrectly described in said ordinance; and,

WHEREAS a corrected plat and description has been made and is attached hereto for greater certainty, NOW, THEREFORE:

THE COUNCIL OF THE VILLAGE OF FORTILL, MONTANA, ORDAINS AS FOLLOWS:

✓ That Subsection 2, "Territory Annexed" of Chapter XV, Section 150 of the Ordinance Extending the Corporate Limits of the Village of Fortill to include Certain Unincorporated Unplanted Land not exceeding 200 acres in area abutting upon the Village Limits be, and it hereby is, amended to delete the description contained in the Ordinance adopted on said 16th day of March, 1954, and that the following description be substituted therefor, to-wit:

"all that part of Southwest Quarter (SW 1/4) of Section 21, Township 125 North, Range 23 West described as follows:
Beginning at the Northwest corner of Southeast Quarter of Section 21, Township 125N, Range 23W; thence South 00°17'30", 1517 feet, more or less, to shoreline of White River; thence Northwestwardly on said shoreline to a line drawn parallel to and 621.70 feet West of East Line of said Southwest 1/4 of Section 21 measured at right angles thereto thence North 00°27'40" on said parallel line 310 feet, more or less, to centerline of First Street North; thence North 70°57' N. on said centerline 116.7 feet; thence North 50°07' N. 308.57 feet; thence North 70°07' N. 399.28 feet; thence South 00°22'10" W. 244.87 feet to West Line of Oak Hill Addition extended; thence North 00°29'40" on said West Line of Oak Hill Addition extended 643.64 feet to North Line of said Southwest 1/4 of Section 21; thence East 1910.38 feet on said North line to point of beginning excepting therefrom the North 400 feet of Road 641 feet and excepting the following, to-wit:
Commencing at point of intersection of North right-of-way line of said First Street North with said East Line of Southwest 1/4 of Section 21; thence North 00°55'1" on said North right-of-way line 117.15 feet; thence North 70°57' N. on said right-of-way line 405.88 feet for point of beginning; thence North 70°57' N. on said right-of-way line 10.65 feet; thence North 50°07' N. on said right-of-way line 237 feet; thence North 22°59'12", 131.10 feet; thence South 50°07' E. 232.13 feet; thence South 10°34'59" N. 132.95 feet to point of beginning."

ORDINANCE CHAPTER XV SECTION 150

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SARTELL TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

February 3rd,

WHEREAS, a certain petition dated February 3rd, 1964, requesting annexation of the territory hereinafter described was duly presented to the Village Council of the Village of Sartell on the 3rd day of February, 1964; and,

whereas, the quantity of land embraced within the area described in the petition and bounded as described is 23.78 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and,

WHEREAS, the petition was signed by all of the owners of said land; and,

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the Village Limits at the Westerly boundary thereof; NOW, THEREFORE:

THE COUNCIL OF THE VILLAGE OF SARTELL, MINNESOTA, ORDAINS AS FOLLOWS:

Subsection 1. The village council hereby determines that the annexation will be to the best interest of the Village and of the territory affected; that the territory described herein abuts upon the Village limits and is about to become urban or suburban in character; and that none of said territory is now included within the limits of any City, Village, or Borough.

Subsection 2. Territory Annexed. The corporate limits of the Village of Sartell are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

That part of Southwest Quarter of Section 2k, Township 125 Range 28 West, Stearns County, Minnesota, described as follows:

"Commencing at Northeast corner of Southwest Quarter (SW 1/4) of Section 21, Township 125 North, Range 28 West; thence 500 degrees 20 minutes on East line of said Southwest 1/4 to Southerly right of way line of a public road; thence West on said right of way line 125 feet; thence North 76 degrees 40 minutes West on said right of way line 305 feet; thence 500 degrees 20 minutes East a distance of 285 feet, more or less to shoreline of Watab River; thence Southeasterly on said shoreline to the East line of said Southwest Quarter of Section 21; thence North 00 degrees 20 minutes West on East line of Southwest Quarter a distance of 374.5 feet, more or less to point of beginning."

ALSO; That part of South One-Half (S 1/2) of Section 21, Township 125 N. Range 28 West Stearns County, Minnesota, described as follows:

"Beginning at center of Section 21, Township 125 N. Range 28 West; thence South on East line of Southwest Quarter (SW 1/4) of said Section 21 to a point on South right of way line of 1/2 Street North (formerly Elm Street), Village of Sartell; thence East on said South right of way to West right of way line of Fifth Avenue North; thence South on said West right of way line to Northeasterly right of way line of a Township Road; thence

Northwesterly of said northerly right of way line to point on West Line of Lot 3422; addition extended northerly; thence North following an existing street line and said fence line extended to North line of Northwest 1/4 of Section 21; thence West on said North line of Northwest 1/4 to point of beginning, subject to road right of way over North 39 feet, excepting therefrom the North 490 feet of West 341 foot and except the following: " commencing at point of intersection of East line of Northwest 1/4 of Section 21, Township 32S R. Wango 29 West with North right of way line of aforementioned New Hwy Road; thence northerly on said right of way line 127.35 feet; thence deflect right 13 degrees 08 minutes a distance of 406.00 feet to point of beginning; thence northerly at eight miles 182.37 feet; thence northerly at 23 71 degrees 50 minutes a distance of 322.15 feet; thence deflect left 90 degrees 00 minutes a distance of 191.10 feet to Northerly right of way line of Township Road; thence northerly on said right of way line to point of beginning."

Subsection 3 Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Subsection 4. Effectuation Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Subsection 3 hereof.
