ORDINANCE NO. 189
AN ORDINANCE EXTENDING
THE CORPORATE LIMITS OF
THE CITY OF EAST GRAND
FORKS TO INCLUDE CERTAIN
UNPLATTED LAND IN GOVERNMENT LOT 9, SECTION 12,
151-50, NOT EXCEEDING 200
ACRES, BEING 1.968 ACRES,
MORE OR LESS, AND REPEALING ORDINANCE NO. 185.

The City Council of the City of East Grand Forks, Minnesota, do hereby ordain as follows:

Section 1. Ordinance No. 185 of the City of East Grand Forks, Minnesota, is hereby repealed in its entirety.

Section 2. A Petition for Annexation has been filed with the City Council of the City of East Grand Forks, Minnesota, by the Community Christian Reformed Church, a Non-Profit Corporation under the Laws of the State of Minnesota, and the City of East Grand Forks, Minnesota, a Municipal Corporation, under the Laws of the State of Minnesota, the sole owners of the following described real estate. to have such land included within the City of East Grand Forks, Minnesota; that Copies of said Petition were filed with the Rhinehart Township Board on August 1, 1963, with the Polk County Board on August 8, 1963, and with the State of Minnesota Municipal Commission; that said land is described as follows, to-wit:

A tract of land in Government Lot Nine (9), Section Twelve (12), Township One Hundred Fifty-one (151) North, Range Fifty (50) West of the Fifth Principal Meridian, County of Polk and State of Minnesota, which tract is described as follows, to-wit:

Commencing at the Northeast corner of Government Lot 9. Section 12, Township 151 North, Range 50 West of the Fifth Principal Meridian, said corner being also the center of said Section 12, and being also the Southeast Corner of Mikkelson & Reilly's 3rd Addition to the City of East Grand Forks, Minnesota thence proceeding westerly along the north line of said Gov't. Lot 9, said north line being also the south line of Mikkelson & Reilly's Additions, a distance of 40.00 feet to the true point of beginning; thence continuing westerly along the said north line of Gov't. Lot 9 a distance of 460.00 feet to a point 500 feet distant westerly from the said Northeast corner of Gov't. Lot 9; thence deflecting left and proceeding southerly, on a line ly-

ing parallel to the east line of Gov't. Lot 9, a distance of 40.00 feet: thence deflecting left and proceeding easterly, on a line lying parallel to the north line of Gov't. Lot 9, a distance of 206.00 feet; thence deflecting right and proceeding southerly, on a line lying parallel to the said east line of Gov't. Lot 9, a distance of 265.00 feet; thence deflecting left and proceeding easterly, on a line lying parallel to the said north line of Gov't. Lot 9, a distance of 254.00 feet to a point 40 feet west from the east boundary of said Gov't. Lot 9; thence deflecting left and proceeding northerly, parallel to and 40.00 feet distant westerly from the said East line of Gov't. Lot 9, a distance of 305.00 feet to the true point of beginning, with said tract containing approximately 1.968 acres lying wholly within Gov't. Lot 9, Section 12, Township 151 North, Range 50 West of the 5th Principal Meridian. County of Polk and State of Minnesota.

Section 3. The quantity of land embraced within the foregoing description is 1.968 acres, more or less.

Section 4. The City Council hereby determines (1) that the quantity of land embraced within the foregoing description is less than 200 acres; (2) that the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected: (3) that the territory and land described as above abuts upon the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government, and is urban in character; (4) that the petitioners are the sole owners of the land and real estate herein described.

Section 5. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2, and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Commission, the County Auditor and the Secretary of State of the State of Minnesota.

Section 7. This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 6, and be given the number 189.

Gent lemen:

There is considerable confusion as to the status of the above annexation Ordinance, which has arisensby virtue of the amendment to Minnesota Statutes Section 414.03, subdivision 2, which was passed by the 1963 Minnesota Legislature. As to the above amendment, the law was effective and applied to all petitions and ordinances for annexation which had not been passed and filed prior to May 22, 1963. As to all other amendments, the new law did not apply until after July 1st.

The advice from your office, pursuant to your letters of August 16th, 1963, and February 6, 1964, was that this annexation Ordinance had mett all requirements of the Municipal Commission, and your office accepted the Ordinance for filing on August 9, 1963.

However, the office of the Secretary of State has taken a contrary position, and has indicated that because of the amendments made by the 1963 legislature, the annexation was defective, and accordingly refused to accept it for filing.

Accordingly, we are abendoning the prior annexation. A new Petition for Annexation was filed with the City Council of East Grand Forks, Minnesota, on July 9, 1963. Copies of that petition were filed with the Township of Rhindhart, in which township the subject property is situated, on August 1, 1963, and filed with the County Board of Polk County, in which county the subject property is situated, on August 8, 1963.

I am at this time enclosing for filing in your office two copies of the new "Petition for Annexation", along with the certificate of the City Clerk of the City of East Grand Forks attesting to the filing of copies with the Town Board and the County Board on the dates set forth above.

As will be immediately ascertained, more than 30 days have clapsed since the filing of the above Petition with the county and township, and the new Annexation Ordinance will be introduced to the City Council in the immediate future. Amongst other things, the new Ordinance will annul the prior Ordinance No. 185.

I hope this letter and enclosures will clarify the situation. The Ordinance No. 185 which you now have on file should be ignored. If you have any questions what-spayer, please feel free to inquire of this writer. I regret the confusion which has ensued.
