

ORDINANCE NO. 190

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS TO INCLUDE CERTAIN UNPLATTED LAND IN THE NORTHWEST QUARTER OF SECTION 35 IN GRAND FORKS TOWNSHIP, POLK COUNTY, MINNESOTA, NOT EXCEEDING TWO HUNDRED ACRES

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by Vivian E. Harney, the sole owner of the land hereinafter described, to have such land included within the City limits of the City of East Grand Forks, Minnesota; that copies of said petition were filed with the Minnesota Municipal Commission, the Town Board of Grand Forks Township and the County Board of Polk County, Minnesota; that more than 30 days have elapsed since such filings of said petitions and that no objections have been filed as is more fully shown by the records and files herein.

Section 2. That the tract of land being annexed is described as follows, to-wit:

That part of the Northwest Quarter (NW $\frac{1}{4}$) of Section Thirty-five (35), Township One Hundred Fifty-two (152) North, (Grand Forks Township) Range Fifty (50), West of the Fifth Principal Meridian, more particularly described as follows, to-wit: Commencing at the center of Section 35, Township 152 North, Range 50, West of the 5th Principal Meridian; thence proceeding westerly along the East-West Quarter Section line of Section 35 for a distance of 1360.00 feet to the Southeast corner of Wurden's 4th Addition to the City of East Grand Forks, Minnesota; thence deflecting right and proceeding northerly along the easterly line of said Wurden's 4th Addition for a distance of 1180.00 feet to the Northeast corner of said Wurden's 4th Addition which corner lies on the West line of Wurden's 5th Addition to the City of East Grand Forks, Minnesota, and which corner is the true point of beginning; thence continuing northerly along the northerly projection of the said easterly line of Wurden's 4th Addition and along the Westerly line of the said Wurden's 5th Addition for a distance of 160.00 feet to the Northwest corner of the said Wurden's 5th Addition; thence

deflecting left and proceeding westerly on a line lying parallel to and 160.00 feet distant from the Northerly line of the said Wurden's 4th Addition for a distance of 952.04 feet to a point of intersection with a line lying parallel to and 340.00 feet distant easterly from the Westerly line of said Section 35; thence deflecting left and proceeding southerly along said line lying parallel to and 340.00 feet distant easterly from the West line of the said Section 35 for a distance of 160.00 feet to the Northerly line of the said Wurden's 4th Addition; thence deflecting left and proceeding easterly along the said Northerly line of Wurden's 4th Addition for a distance of 951.31 feet to the true point of beginning, with said described tract comprised of 3.496 acres lying wholly in the Northwest Quarter of Section 35, Township 152 North, Range 50 West of the 5th Principal Meridian, County of Polk, State of Minnesota.

Section 3. That the quantity of said land herein described is 3.496 acres.

Section 4. The City Council hereby determines (1) that the quantity of land embraced within the foregoing description is less than 200 acres; (2) that the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected; (3) that the territory and land described as above abutts upon the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government and is urban in character; (4) that the petitioner is the sole owner of the land and real estate herein described.

Section 5. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2, and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Commission, the County Auditor and the Secretary of State of the State of Minnesota.

Section 7. This ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 6 and be given the number 190.


