ORDINANCE NO. 196

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SAUK RAPIDS TO INCLUDE CERTAIN TERRITORY OWNED AND NOT EXCLUDING PURCHASED LAND.

Section 15:36 (1) A petition has been filed with the governing body of the Village of Sauk Rapids, Minnesota, by all of the owners of the following described real estate to have such land included in the Village of Sauk Rapids:

The North 175 feet of the West 240 feet of that part of the Southwest Quarter of the Southwest Quarter (S.W. of S.W.) of Section Twenty-four (24) Township Thirty-six (36) North, Range Thirty-one (31) West, Fourth Principal Meridian, lying Southerly of the Southerly line of First Street South in the Village of Sauk Rapids.

(2) The quantity of land embraced in the foregoing description, and bounded as described is .964 acres more or less.

(3) Notice of this proposed annexation was given to the Township of Sauk Rapids, County of Benton, and to the Minnesota Municipal Commission more than 30 days previous.

(4) The Village Council hereby determines (1) that the annexation will be to the best interests of the Village of Sauk Rapids, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the Village of Sauk Rapids and is so conditioned as properly to be subjected to Village government.


(5) Therefore, the Village of Sauk Rapids, Minnesota, hereby ordains and declares that the property herein before described by and the same is hereby annexed to, and included in, the Village of Sauk Rapids, Minnesota, as effectually as if it had originally been a part thereof.

(6) This ordinance shall be final and shall take effect and be in force from and after filing Certified copy thereof with the Minnesota Municipal Commission, and the County Auditor, and the Secretary of State, and from and after its passage and publication.


