WHERPAS. EASTGATE TEVELOPMENT CORPORATION, a corporation under the laws of the State of Hinnesota, and Moorhead Mursing Home, Inc., a corporation under the laws of the State of Minnesote, are the owners and proprietors of a certain tract of land containing 17.901 acres, more or less, abutting upon the said City on the cast and more particularly described as follows:

VHERBAS, the Moorhead City Planning Commission did on the 18th day of July, 1962 make its resolution of approval thereof,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Moorhead as follows:

Section 1. That the above described property is hereby annexed to the City of Moorhead and the same declared to be an addition to and a part of the City of Moorhead, to be hereafter called and known as Pastgate First Addition.

Section 2. All ordinances or parts of ordinances thereof inconsistent horewith are horeby repealed.

Section 3. This ordinance shall take effect from and after its passage, approval and publication.
