ORDINANCE ANNEXING REAL ESTATE

Ordinance No. 376

WHEREAS, a certain petition dated June 29, 1964, requesting annexation of land hereinafter described was duly presented to the Council on the 6th day of July, 1964; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 159.22 acres of unplatted land, no part of which is included within the limits of any incorporated city, village, or borough; and,

WHEREAS, the petition was signed by the owner of all of the real estate involved; and,

WHEREAS, no objection to the annexation has been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and,

WHEREAS, the land described in the petition abuts upon the city limits at the southeasterly boundary thereof;

The City Council of the City of Moorhead ordains:

Section 1. The City Council hereby determines (1) that the annexation will be in the best interests of the City of Moorhead and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof, said land described as follows: The Southeast Quarter (SE $\frac{1}{4}$) of Section Sixteen (16), Township One Hundred Thirty-nine North (139N), Range Forty-eight West, (48W) Fifth Principal Meridian, excepting all that part of said subdivision lying westerly of a line parallel with and distant 100 feet easterly, measured at right angles, from the center line of main track of the railway of the Great Northern Railway Company, as now located and constructed, containing an area of 159.22 acres, more or less.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
