

#### ORDINANCE NO. 312

# Sources of States

### AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF DETROIT LAKES TO INCLUDE CERTAIN PLATTED LAND

THE COUNCIL OF THE CITY OF DETROIT LAKES DOES ORDAIN:

Section 1. A petition has been filed with the governing body of the City of Detroit Lakes, Minnesota, by a majority of the owners in number of the following described roal estate to have such land included within the City of Detroit Lakes, Minnesota:

> All of E. C. Carlson Subdivision as located in Government Lot Two (2), Section Three (3), Township 158 North of Range 41 West of the 5th P.M.

All of John R. W. Sargent's Subdivision as located in Government Lot Two (2), Section Three (5), and in Government Lot One (1), Section Four (4), Township 138 North of Range 41 West of the 5th P.M.

All of W. O. Anderson Subdivision as located in Government Lot One (1), Section Four (4), Township 138 North of Range 41 West of the 5th P.M.

All of W. O. Anderson Subdivision First Addition (including all the Rearrangements of Blocks Two (2) and Three (3) of said Addition) as located in Government Lot One (1), Section Four (4) Township 138 North of Range 41 West of the 5th P.M.

All of Lot Four (4) of JOHN A. BOWMAN'S Subdivision as located in Government Lot One (1) of Section Four (4), Township 138 North of Range 41 West of the 5th P.M.

Including all streets and alleys as designated on the plats thereof on file and of record in the Office of the Register of Deeds, Becker County, Minnesota.

Section 2. The Quantity of land embraced within the foregoing description, and bounded as described is twenty seven (27) acres.

Section 3. A hearing was duly held by the governing body of the City of Detroit Lakes, Minnesota, on the proposed annexation after at least 30 days posted notice.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Detroit Lakes, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City of Detroit Lakes and is so conditioned as properly to be subjected to the City government.

Section 5. Therefore, the City of Detroit Lakes, Minnesota, hereby ordains and doclares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Detroit Lakes, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. This Ordinance shall be final and shall

take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
