

VILLAGE ORDINANCE NO. 31.

AN ORDINANCE ANNEXING CERTAIN LANDS IN WHOLE DESCRIBED TO THE
VILLAGE OF GILBERT.

The Village Council of the Village of Gilbert, St. Louis County,
Minnesota do ordain as follows:

Section 1. Oneida Iron Company, a Minnesota corporation, being
the sole owner of that tract, piece or parcel of land laying and being
in St. Louis County, Minnesota, and described as follows: The Southeast
quarter of the Southeast quarter (33 $\frac{1}{4}$ of the 36 $\frac{1}{4}$) of Section Twenty-
three (23), in Township Fifty-eight (58) North, of Range Seventeen (17)
West of the Fourth Principal Meridian, said lands abutting upon the
territory now included within the Village, having petitioned the Vil-
lage Council of the Village of Gilbert to have said lands included
within the corporate limits of said Village and annexed to said Village;

IT IS HEREBY ORDAINED, ENACTED AND DECLARED that said tract, piece
or parcel of land above described be, and the same hereby is, annexed
to the said Village of Gilbert, and is an addition to said Village, and
the boundaries and corporate limits of said Village are hereby extended
so as to include said land, and said land shall be, and hereby does, be-
come a part of said Village as effectually as if it had been originally
a part thereof.

Section 2. The Village Recorder of the Village of Gilbert shall
cause a certified copy of this ordinance to be recorded and filed in the
office of the Register of Deeds of St. Louis County, in the same manner as
city or Village charters are filed and recorded under the General Laws
of this State.

Section 3. This ordinance shall take effect and be in force from
and after its passage and publication.

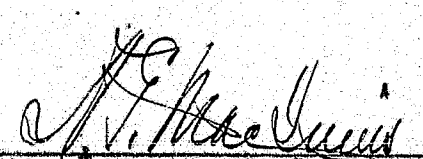
On motion of Trustee Kohler supported by Trustee Clifford the
