

1.21 AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF PIPESTONE, MINNESOTA.

The Common Council of the City of Pipestone, Minnesota do ordain as follows:

Section 1 The land described as follows to-wit:

all that part of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 12, Township 106, Range 46, described as follows: Beginning at a point 40 feet west of the northwest corner of Lot 6, Block 7, Original Plat to the City of Pipestone, Minnesota; thence West along the South line of 4th St. Northwest of said City of Pipestone, 363.0 feet to a point; thence South along the Northerly extension of the East line of 6th Ave. Northwest of said City of Pipestone 251.7 feet to a point; thence east along the North line of the right-of-way of the Chicago, Milwaukee, St. Paul and Pacific Railway 361.0 feet to a point, thence Northerly 257.5 feet to the place of beginning, all in the County of Pipestone and State of Minnesota; now owned by the County of Pipestone and being contiguous to and abutting on the corporated limits of the City of Pipestone, is hereby declared to be a part of the City of Pipestone.

Section 2 This ordinance shall take effect and be in force from and after its passage and publication.
