IN THE MATTER OF THE PETITION FOR THE DETACH-
MENT OF PROPERTY FROM THE VILLAGE OF VERDALE
WADENA COUNTY, STATE OF MINNESOTA

The petition of certain freeholders for the detachment of property from the Village of Verdale, Wadena County, Minnesota, came on for hearing before the Minnesota Municipal Commission in the Verdale Village Hall, Verdale, Minnesota on the 15th day of December, 1964. Robert W. Johnson, Vice-Chairman, and Torrance O'Toole, Commissioner, attended the hearing together with Irving H. Keldsen, Secretary. Joseph Robbie, Chairman, read and examined the record and exhibits.

The Commission having duly considered the testimony of the witnesses, the exhibits received in evidence and all other evidence and upon all the files and records, being fully advised in the premises, makes and enters the following:

FINDINGS OF FACT

I.

Due, timely, and adequate legal notice of the hearing herein, was posted, published, served and mailed.

II.

That the requisite number of property owners have executed said petition.

III.

That the property is unimproved and used and occupied exclusively for agricultural purposes.

IV.

That the property is within the boundaries of the Village of Verdale, County of Wadena, and State of Minnesota, a Municipal Corporation, and is adjacent to said boundary thereof.

V.

That the land described herein is not needed for reasonably anticipated future development of the said Village of Verndale.

CONCLUSION OF LAW

That the land described herein should be detached from the Village of Verndale, Wadena County, State of Minnesota, and that said property is to become a part of Aldrich Township, Wadena County, State of Minnesota.

ORDER

IT IS ORDERED: That the following described land shall be detached from the Village of Verndale, Wadena County, State of Minnesota, and become a part of Aldrich Township, Wadena County, State of Minnesota, the same as if it had originally been made a part thereof:




IT IS FURTHER ORDERED: That the present bonded indebtedness
