AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LITTLE FALLS TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and,

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the city and is deemed to be urban in character:

The City Council of the City of Little Falls do ordain:

Section 1. Territory Annexed. The corporate limits of the city of Little Falls, Minnesota, is hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits.


A parcel of land described as follows: Commencing at the Northwest corner of the Southwest Quarter of Southwest Quarter, Section Nine (9), Township forty (40), Range Thirty-two (32), thence running east 26 feet to the point of beginning, thence east $203\frac{1}{2}$ feet, thence at right angles South 214 feet, thence at right angles West $203\frac{1}{2}$ feet, thence at right angles North to the point of beginning.

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This Ordinance shall take effect 30 days after its passage and publication and the filling of certified copies as directed in section 2.


