## OUNTHANCE NO. 365

AN ONDINANCE EXTENSING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, PRINCESCEA, TO INCLUDE CHPTAIN UNPLATTED LAWER.

The City Council of the City of Worthington Do Ordains

Section 1. The territory hereinafter described, is now owned by the City of Worthington; and whereas said property is situated outside of, but contiguous to, and abutting on the corporate limits of the City, the City Council of said City of Worthington has determined to have such land included within the City of Worthington, Minnesota:

Commencing at a point on the section line between Sections Thirteen and Twenty-four (13 & 24), Township One Hundred Two (102) North, Range Forty (40) West; 70 feet West and 35 feet South of the Southwest corner of Lot Eight (8) of the Plat of North Worthington Addition, (kity of Worthington; thence North and parallel to the West line of said Section Thirteen (13), a distance of 662.5 feet, and which line is also the East line of the parcel of land as described in a certain Warranty Deed dated October 31, 1963, and recorded December 24, 1963, in the office of the Register of Deeds, Nobles County, Minnesota, as Document No. 164303; thence East and parallel to the South line of said section, a distance of 662.5 feet to the West line of said section, a distance of 662.5 feet to the South line of said section; thence West along said section line 70 feet to the point of beginning, to be used for street purposes.

and

Commencing at a point on the section line between Sections Thirteen and Twenty-four (13 & 2h), Township One Hundred Two (102) North, Range Forty (40) West, 70 feet West and 35 feet South of the Southwest corner of Lot Eight (8), of the Flat of North Worthington Addition, City of Worthington; thence Northerly and parallel with the West line of Section Thirteen (13) a distance of 650.5 feet to the point of beginning; thence Westerly and parallel to the South line of Section Thirteen (13) a distance of 115 feet; thence Southerly and parallel to the West line of said section Thirteen (13) a distance of 15 feet; thence South line of Section Thirteen (13) a distance of 15 feet; thence Easterly and parallel to the South line of Section Thirteen (13) a distance of 115 feet to the point of beginning, to be used for alley purposes.

Section 2. The quantity of land embraced within the foregoing descriptions, and bounded and described is 1.10 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Northington Township on October 23, 1964, that said matter was being considered by the City Gouncil of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed ammexation after publication of notice of hearing as required by City Charter.

Section h. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is hereby amount to, and included in the City as effectually as if it had oxiginally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Corporation, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon the filing of the certified copies as directed in Section 6.
