

CITY OF WORCESTER NO. 362

AN ORDINANCE BY WHICH THE CORPORATE LIMITS OF THE CITY OF WORCESTER,
MINNESOTA, IS ADDED CERTAIN UNINCORPORATED LANDS.

The City Council of the City of Worthington Do Ordain:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following described real estate, to have such land included within the City of Worthington, Minnesota:

That part of the SE^{1/4} of Section 15, Township 102, Range 10, Nobles County, Minnesota, described as follows: Commencing at the Southeast corner of said Section 15, and thence Westerly on the South line of said section for a distance of 991.0 feet, thence North 00 degrees 00 minutes West (advised bearing) for 75 feet, to the point of beginning; thence North 90 degrees 00 minutes West for 370.3 feet; thence North 00 degrees 00 minutes West for 244 feet; thence North 90 degrees 00 minutes West for 221.51 feet; thence North 00 degrees 13 minutes West for 365 feet; thence North 90 degrees 00 minutes East for 777.5 feet; thence North 45 degrees 03 minutes East for 167.27 feet, zero or less, to the centerline of diagonal road; thence South 44 degrees 57 minutes East on the centerline of diagonal road for 112.15 feet; thence South 00 degrees 00 minutes West for 327.85 feet; thence South 90 degrees 00 minutes West for 391 feet; thence South 00 degrees 00 minutes West for 226.0 feet, to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is 9.6 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on September 26, 1964, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the city are extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Corporation, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon the filing of the certified copies as directed in Section 6.
