

ALL CITIZENS LIVING IN THE COUNTRY TERRITORY OF THE CITY OF WORTHINGTON,
MINNESOTA, TO BECOME CITYLAND OWNERSHIP LAND.

The City Council of the City of Worthington Do Ordain:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following described real estate, to have such land included within the City of Worthington, Minnesota:

A tract of land in the Southwest Quarter (SW^{1/4}) of Section Thirteen (13), Township One Hundred Two (102) North, Range Forty (40) West of the 5th P.M. in the County of Nobles, described as follows: Commencing at the Southeast corner of Section Thirteen (13), Township One Hundred Two (102) North, Range Forty (40) West of the 5th P.M., thence North along said section line, a distance of 1157 feet; thence East and parallel to South line of said section, a distance of 460 feet to the point of beginning; thence South and parallel to West line of said section 40° 00', a distance of 491.5 feet; thence South 30° 02' East, a distance of 360.8 feet; thence North 09° 00', a distance of 861.5 feet; thence North 09° 02' West, a distance of 360.8 feet; thence South 09° 00'; a distance of 370 feet, to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described in 7.3 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on September 25, 1964, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein comes upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as officially as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Corporation, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon the filing of the certified copies as directed in Section 6.
