AN ORPERATOR EXPERIENCE THE OCRPORATE LIMITS OF THE CITY OF WORTHINGTON, MINISTECTA, TO INCLUDE CERTAIN PLATTED LAND.

The City Council of the City of Worthington Do Ordain:

Section 1. A patition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following described real estate, to have such land included within the City of Worthington, Minnesota:

Lot One (1), Block Six (6), Auditor's Plat of Government Lot One (1), Section 27, Township 102 North, Range 40 West, Wobles County, Minnesota.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described is .48 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on Cotober 22, 1964, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed amenation after publication of notice of hearing as required by City Charter.
