
NOTICE OF HEARING

NOTICE IS HEREBY GIVEN That a hearing will be held by the Council of the City of Detroit Lakes, Minnesota on Tuesday, the 1st day of December, 1964, at 7:30 o'clock P. M. in the Council Chambers of the City Hall of the City of Detroit Lakes, Minnesota, to act on the proposed annexation to the City of Detroit Lakes the following described property located in the County of Becker, State of Minnesota:

All of Mountain View 1st Addition, except the West Thirty-two (32) feet, according to the certified plat thereof and the metes and bounds description contained in said plat on file and of record in the office of the Register of Deeds in and for Becker County, the West Thirty-two (32) feet of said Addition being already annexed to and a part of the City of Detroit Lakes.

All interested persons are invited to attend said hearing at the above time and place.

ORDINANCE NO. 314

An Ordinance Extending the Corporate Limits of the City of
Detroit Lakes to Include Certain Platted Land

The Council of the City of Detroit Lakes Does Ordain:

Section 1. A petition has been filed with the governing body of the City of Detroit Lakes, Minnesota, by a majority of the owners in number of the following described real estate to have such land included within the City of Detroit Lakes, Minnesota:

All of Mountain View 1st Addition, except the West Thirty-two (32) feet, according to the certified plat thereof and the metes and bounds description contained in said plat on file and of record in the office of the Register of Deeds in and for Becker County.

Section 2. All of the land embraced within the foregoing description is platted.

Section 3. On October 24, 1964, a copy of the petition for annexation was filed with the Clerk of Detroit Township and the Auditor of Becker County, the Township and County wherein the above described premises are located. No objection was received from either the Township or the County to the proposed annexation.

Section 4. A hearing was duly held by the governing body of the City of Detroit Lakes, Minnesota, on the proposed annexation after at least 30 days posted notice.


Section 5. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Detroit Lakes, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City of Detroit Lakes and is so conditioned as properly to be subjected to the City Government.

Section 6. Therefore, the City of Detroit Lakes, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Detroit Lakes, Minnesota, as effectually as if it had originally been a part thereof.


Section 7. This Ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
