ORDINANCE 15

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF WOLF LAKE TO INCLUDE CERTAIN PLATTED AND UN-PLATTED LAND NOT EXCEEDING 200 ACRES IN AREA.

WHEREAS, a certain petition dated March 31, 1964, requesting annexation of the territory described below was duly presented 0 < 0 to the council on the 14th day of April, 1964.

The Council of the Village of Wolf Lake ordains:

Section 1. Declaration. It is hereby determined that the territory described below abuts upon the village and is so conditioned as properly to be subjected to village government.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the territory described as follows:

"Gommencing at the Southeast corner of Outlot 8, in Block 8 of the Original Townsite of Wolf Lake, according to the Certified Plate thereof on file; thence Southeasterly on and along the Westerly line of public highway a distance of 300 feet which is the point of beginning, thence West and parallel with the south line of Outlot 8 a distance of 132 feet; thence Northwesterly and parallel with said public road a distance of 300 feet, thence Easterly parallel with the south line of said OutLot 8 a distance of 132 feet and thence Southeasterly 300 feet to the point of beginning." (Or the Fractional N. E. Quarter of the N. E. Quarter of Section 4 in Township 138 North of Range 37 - West of 5th Principal Meridian in Becker County, Minnesota.)

Section 3. Filing. The village clefk is hereby directed to file certified copies of this ordinance in the office of the Secretary of State of Minnesota and in the office of the county auditor of Becker County.

Section 4. Effective Date of Annexation. Annexation shall be complete from and after the date when certified copies of this ordinance have been filed as directed in section 2.
